Argyll and Bute Council, in conjunction with the Helensburgh Outdoor Museum Design Panel, are inviting entries from local groups and individuals to win the chance to create a new artwork for the Outdoor Museum in Colquhoun Square.

The winner will work with an appointed artist who will design, create and install an artwork up to a value of £6,000.

The deadline for submission of entries is 10<sup>th</sup> November 2025.

#### **Guidelines**

Community organisations and individuals are eligible to apply.

We welcome entries from children and young people. Anyone under the age of 16 will require a parent/guardian or trusted adult to provide contact information. Anyone under the age of 18 who wins the competition, will require a parent/guardian or trusted adult to give permission and be present for meetings with the appointed artist.

The design development will take place between January and April 2025, the winner will be required to be available to meet with the appointed artist during this time.

Winners will be notified by 11th December 2025.

## Ineligible entries

The proposed artwork cannot:

- Advertise business
- Be party political in intention or designed to support a political party
- Cause offence i.e. likely to be upsetting, insulting, or objectionable to some or most people

#### **Your Personal Data**

#### What information do we need?

## Why we need this information?

Your information is being collected to provide Argyll and Bute Council, who are responsible for the Helensburgh Outdoor Museum, with information to allow them to contact you about your competition entry.

## What we will do with your information?

In order to provide this service to you, we will share your information with the organisations listed below for the purposes specified.

- The Helensburgh Outdoor Museum Design Panel who will be assessing competition entries. The Design Panel is made up of the Chair and Vice Chair of Helensburgh and Lomond Area Committee, as well as representatives from local organisations and the community with expertise in the arts, culture and heritage.
- 2. The artist who is appointed to deliver the project will be given contact information for the competition winner.

From the point of your competition entry being made, Argyll and Bute Council will retain the information provided on your entry form for the purposes of determining the competition winner and making contact with you in this regard. We will use your information to acknowledge receipt of your entry, to contact you about the outcome of the competition and share the name and organisation of the competition winner publicly.

You should be aware that your data will be stored on servers located within the United Kingdom. We will take all reasonable steps to ensure that your data is kept secure and more information on how we do this can be provided by contacting the Data Protection Officer (contact details can be found above).

### How long will we keep your information?

We will keep your information for 5 years after which it will be destroyed under secure arrangements. More information on our retention policy can be obtained from the Data Protection Officer (contact details can be found above).

# Your Rights

When you provide information to the Council, you will have the following rights:
